Hence keeping the above guidelines at priority, the members of the committee is authorised to the necessary measures.

AGENDA 1

The members after perusal of the concerned documents and directions, unanimously resolved that

A. RAGGING IS NOT ALLOWED IN ANY MANNER AT THE COLLEGE CAMPUS OR IT'S STAKEHOLDERS.

B. Ragging & sexual harassment are now defined as an act that violets or is perceived to violate an individual's dignity. It has ruined countless innocent lives and careers, hence both are strictly not allowed

C. The following strategies are maintained in our college to prohibit ragging & sexual harassment : -

- a) The college ensures that all employees understand the policies & procedures for dealing with harassment.

- b) Actions are taken to eliminate discriminatory jokes, posters, graffiti, e-mails, whatsapp. Facebook posts and photos at the work site.
- c) The college takes sufficient measures to identify the harasser immediately and warns that his/her action is of offensive nature.
- d) Any victim may complain in writing to the Principal or to 'Prevention against sexual harassment cell' which would be kept confidential.

AGENDA 2

Members perused the decisions of Hon'ble Supreme Court with regard to the Ragging and its hazards on higher education intuitions and their directions there off , and finally opined that :

- i. The members of the cell will keep regular updates of the direction and instructions given by UGC, University, and Government in curbing the menace of Ragging and sexual harassment, if any.
- ii. The members agrees themselves that to become regularly updated with the above mentioned direction a computer versed member is required in the committee/ cell to get ourselves with latest updates. Hence a request in this regard to the principal be made with this agenda and resolution to nominate any such person / employee who is computer versed.
